Guest: Angelina Wilson from Tarheel Challenge Academy gave a presentation. This academy serves 16-18-year-old at-risk boys and girls; this is sponsored by the National Guard; this is a volunteer program. They serve students from all 100 counties; the program is a seventeen and half month program with two phases, they can't have a felony and must pass a physical, this program is fully funded and free to parents. Updates: Daniel Sevigny gave the council updates stating only thing he had was the monthly report on the numbers from the programs, numbers are increasing and served YTD 152. He also mentions legislative updates HB173 Separate Division Juvenile Justice and Adult Corrections, HB183 Juvenile Court Counselors /Sensitivity Training, HB252 Various Raise the age changes, HB615 Juvenile Court Mental

Health Assessments and Senate bill 207 Various Raise the age changes from 6 to 10. Reach out to your senators and legislators and voice your opinion on these bills.

Old Business: Megan gave updates on the Public Outreach brochure, the first design was using a low quality paper, printing 20,000 in Spanish and 20,000 in English, the committee stated they did not think 20,000 would be used in the FY 20/21, Megan chose a higher quality UV gloss and printing only 10,000 in Spanish and 10,000 in English, all brochures will be trifold. Programs will be listed with information about the program and phone numbers and emails, also added on back would be Joanie Bischer new Admin Clerk information. There will be a PDF done so it can be emailed. Nothing to approve currently, council was comfortable with this decision. No questions or concerns from council members.

New Business: Darryl Bego summited a budget revision to move \$925 from line items#310 (transportation) and \$935 from line items #390 (Juvenile Work Stipends) to line item#450 (Insurance) to pay for \$1,800 insurance shortage for vocational instruction. DPS has approve this Revision if council approves. Motions from David Wall to accept this budget revision and a Second from Connie Philbeck. With no oppose.
