#### 4.1 Active Living and Parks - Senior Center Grants

Byron Hagler, Active Living and Parks Assistant Director, presented information regarding the Senior Center General Purpose and Health Promotion and Disease Prevention grant fund updates (state approved budget) and associated budget amendments. The match for both grants is budgeted in the senior center

salary accounts 9101 and 9103.

#### 4.2 BOC - Appointments to Boards and Committees

Chairman Morris reported information regarding appointments to boards and committees was provided in the agenda. These appointment requests will be included in the Consent section of the April 19, 2022, regular meeting agenda.

#### 4.3 BOC - Resolution Dissolving Advisory Board

Mike Downs, County Manager, reported the Animal Protection Advisory Board was created via resolution by the Cabarrus County Board of Commissioners in 2015 to review the Animal Shelter's policies and procedures when the Humane Society of Concord and Greater Cabarrus County operated the facility. Since then, the Animal Shelter has shifted under the oversight of the Sheriff. The board served strictly as an advisory board. They do not hold a supervisory role to the Animal Shelter or the Sheriff's Office. The current members were contacted, there was little response and no commitment of leadership. Animal Shelter and Sheriff's Office staff feel under the current organizational structure, they are able to achieve the necessary goals without an advisory board.

A brief discussion ensued.

#### 4.4 DHS - Transportation Drug and Alcohol Policy

Charles Ratliff, Department of Human Services (DHS) Transportation Operations and Training Supervisor, reported as part of the Safety System Plan, the Federal Transportation Agency requires a drug and alcohol policy because of the special requirements of transportation. DHS has an additional separate policy along with the County policy. Mr. Ratliff presented the policy for the Board's review. He also responded to questions. Bob Bushey, Transportation Manager, was also in attendance.

#### 4.5 DHS - Transportation Federal Transit Administration Resolution

Bob Bushey, Transportation Manager, reported Cabarrus County will no longer administer the Federal Transit Administration 5307 Grant and will begin applying directly to the Federal Transit Authority. He stated a resolution will be needed authorizing the County Manager and Cabarrus County to do so. Mr. Bushey also responded to questions from the Board.

#### 4.6 DHS - Transportation System Safety Plan

Charles Ratliff, Department of Human Services (DHS) Transportation Operations and Training Supervisor, reported the North Carolina Department of Transportation (NCDOT) requires each transit system to create and maintain a systems safety plan. NCDOT audits each system every three years for compliance in the areas of safety, security practices and policies.

Mr. Ratliff stated, as part of Cabarrus County's audit that occurred this year, the NCDOT requires the Board's approval of the safety plan.

A discussion ensued. During discussion, Mr. Ratliff and Bob Bushey, Transportation Manager, responded to questions.

#### 4.7 Finance - American Rescue Plan Act Funds for Broadband and Nonprofits

Wendi Heglar, Finance Director, presented a proposal to use the unallocated funds from the American Rescue Plan Act Fund for broadband and nonprofits as follows:

- Completing Access to Broadband (CAB) \$2,000,000 county match to expand broadband in rural/underserved communities
- Habitat for Humanity \$500,000 additional funds for the critical home repair program
- Education Foundation \$164,090 funding needed to pilot Reading + Mentoring 4 Success program to address learning loss.
- Conflict Resolution Center \$21,361 funding to address lost revenue resulting from the pandemic

Rodney Harris, Deputy County Manager, and Mike Downs, County Manager, provided additional information regarding the proposal.

A discussion ensued. During discussion, Mr. Harris, Mr. Downs, and Todd Shanley, Chief Information Officer, responded to questions from the Board.

#### 4.8 Finance - American Rescue Plan Act Funds for Cooperative Christian Ministry

Wendi Heglar, Finance Director, reported Cooperative Christian Ministries (CCM) received a \$2,000,000 allocation of ARPA (American Rescue Plan Act) funds. They would like to include the Huddle Housing as an additional approved project.

Rodney Harris, Deputy County Manager, stated CCM's original allocation was for their homeless to housing project, which is to provide transitional housing for those that are experiencing homelessness. He advised the Huddle Housing is more of a longer-term housing CCM would like to be able to use those funds for. Upon approval CCM would be able to use the funds for both projects

A brief discussion ensued.

#### 4.9 Finance - Appropriate Insurance Refund for Ambulance Repair

Kyle Bilafer, Area Manager of Operations, reported an ambulance was involved in an accident on October 23, 2021. The chassis was totaled, and the box was remounted to a new chassis. Insurance funds were received to cover the costs. Mr. Bilafer requested those funds be moved from the insurance account to the general account to cover the cost of the new chassis and remount.

A brief discussion ensued. During discussion, Jimmy Lentz, Emergency Medical Services Director, responded to questions from the Board.

#### 4.10 Finance - Debt Refunding of Limited Obligations Bonds - 2022A

Wendi Heglar, Finance Director, presented a request for debt refunding of Limited Obligation Bonds - 2022A. She stated a public hearing was held last month. Ms. Heglar advised this will require adoption of a resolution to approve refinancing of the prior installment financing contract financings in an aggregate principal amount up to \$130,000,000; the execution and delivery by the Cabarrus County Development Corporation of one or more series of limited obligation bonds related thereto; authorizing the execution and delivery of related documents in connection therewith; and providing for certain other related matters.

Rodney Harris, Deputy County Manager, provided an update regarding the loan term on the new county courthouse project. Mr. Harris advised the loan term will be a 20-year term rather than a 30-year term.

A lengthy discussion ensued. During discussion, Mr. Harris, and Mike Downs, County Manager, responded to questions from the Board.

#### 4.11 Finance - Fire District Property Tax Budget Amendment

Wendi Heglar, Finance Director, presented a request for a fire district property tax budget amendment. She stated this budget amendment will increase Fire Districts' current year property tax collections as well as increase related districts' turnovers. Ms. Heglar also responded to questions from the Board.

# 4.12 Finance - Resolution Approving Installment Financing Contract 2022B Draw-Down LOBS for Various School and County Projects Up to \$160,000,000

Wendi Heglar, Finance Director, reported Cabarrus County plans to enter into one or more short and/or long-term installment financing contracts, including the use of a draw down loan structure with the Cabarrus County Development Corporation or one or more third parties, for an amount not to exceed \$160,000,000 to finance all or a portion of the cost of constructing and equipping public school and county facilities and various real and personal property improvements. She stated the public hearing was held March 21, 2022.

Mr. Harris, Deputy County Manager, stated this is for the courthouse, the EMS Headquarters, the Mount Pleasant Library and Senior Center, and other projects including roof replacements for the school system.

#### 4.13 Finance - Roberta Road Middle School Road Improvements

Wendi Heglar, Finance Director, reported the bid for Roberta Road Middle School Road Improvements came in well over budget. The budget was \$1.7 million, and the bid was just over \$2.8 million. After value engineering the cost will be less than \$2.5 million. All costs are reimbursable by the North Carolina

Department of Transportation (NCDOT). The budget amendment increases the revenue from NCDOT as well as the expenditures.

Brian Cone, Cabarrus County Schools (CCS), Director of Architecture, Planning and Construction, presented a background of the project and estimated costs for the improvements.

A discussion ensued. During discussion, Mr. Cone responded to questions.

UPON MOTION of Vice Chairman Kiger, seconded by Commissioner Shue and unanimously carried, the Board suspended the Rules of Procedure due to time constraints.

**UPON MOTION** of Commissioner Shue, seconded by Commissioner Honeycutt and unanimously carried, the Board approved the budget amendment and capital project ordinance.

# CABARRUS COUNTY SCHOOL CAPITAL PROJECTS BUDGET ORDINANCE

BE IT ORDAINED by the Board of Commissioners of Cabarrus County, North Carolina that, Pursuant to Section 13.2 of Chapter 159 of the General Statutes of North Carolina, the following capital project ordinance is hereby adopted:

#### Section I.

- A. The project authorized is for the construction and renovations of School Facilities. Details of the project are listed in section C. of this Project Ordinance.
- B. The officers of this unit are hereby directed to proceed with this capital project within the terms of the Generally Accepted Accounting Principles (GAAP) and the budget contained herein.

It is estimated that the following revenues will be available to complete capital projects as listed.

#### Section II.

- A. Special appropriations to non-profit organizations shall be distributed after the execution of an agreement which ensures that all County funds are used for statutorily permissible public purposes.
- B. The County Manager or designee is hereby authorized to transfer appropriations within or between funds, or modify revenue and expenditure projections as contained herein under the following conditions:
  - 1. The Manager may transfer amounts between objects of expenditure and revenues within a function without limitation.
  - 2. The County Manager may transfer amounts up to \$500,000 between functions of the same fund.
  - 3. The County Manager may transfer amounts between contingency funds which are set aside for a specific project for budgetary shortfalls or upon the appropriate approval of a change order.
  - 4. The County Manager is authorized to transfer funds from the General Fund or Capital Reserve Fund to the appropriate fund for projects approved within the Capital Improvement Plan for the current fiscal year.
  - 5. Upon notification of funding increases or decreases to existing grants or revenues, or the award of grants or revenues, the Manager or designee may adjust budgets to match, including grants that require a County match for which funds are available.
  - 6. The Manager or designee may adjust debt financing from estimated projections to actual funds received.
  - 7. The County Manager may enter into and execute change orders or amendments to construction contracts in amounts less than \$90,000 when the appropriate annual budget or capital project ordinance contains sufficient appropriated but unencumbered funds.
  - 8. The County Manager may award and execute contracts which are not required to be bid or which G.S. 143-131 allows to be let on informal bids so long as the annual budget or appropriate capital project ordinance contains sufficient appropriated but unencumbered funds for such purposes.
  - 9. The County Manager may execute contracts with outside agencies to properly document budgeted appropriations to such agencies where G.S. 153 A-248(b), 259, 449 and any similar statutes require such contracts.
  - 10. The County Manager may reject formal bids when deemed appropriate and in the best interest of Cabarrus County pursuant to G.S. 143-129(a).
  - 11. The County Manager may reduce revenue projections consistent with prevailing economic conditions, and also reduce expenditures correspondingly.

## Section III.

This ordinance and the budget documents shall be the basis of the financial plan for the County of Cabarrus.

a. The Finance Director is hereby directed to maintain within the Capital Project Fund sufficient detailed accounting records to satisfy the requirements of the law.

- b. The Finance Director is directed to report, at the request of the Board, on the financial status of each project element in Section I and on the total revenues received or claimed.
- c. Copies of this capital project ordinance shall be furnished to the Clerk to the governing Board, and to the Finance Director for direction in carrying out this project.
- d. At the completion of a construction project, all unrestricted excess funds are transferred to the General Fund, Community Investment Fund or other Capital Project Fund and the portion of the Capital Project associated with the project is closed.

## 4.14 Fire Marshal's Office - Ordinance Approval

Steve Langer, Emergency Management Director, presented a request for approval of the proposed fire district ordinance. He stated this is the last step in the process for finalizing the fire district boundary changes that were presented to the Board in March. Those interviews took place during the last week of March 2022. Staff presented the committee's selected finalist for the Courthouse Expansion Public Art Award and announced that Norman Lee was chosen.

A lengthy discussion ensued. During discussion,  ${\tt Mr.}$  Bilafer responded to questions.

Sara Gay, City of Concord, Clearwater Arts Center and Studios Director, and Noelle Scott, Retired Arts Council Director, provided additional comments and information.
