(F-9) County Manager - Resolution Authorizing County Manager to Execute Routine Easement Requests

WHEREAS, N. C. Gen. Stat. \S 153A-12 provides that each power, right, duty, function, privilege and immunity of the County shall be exercised by the Board of Commissioners; and

WHEREAS, N. C. Gen. Stat. \$ 153A-11 provides that a county may acquire and hold, as well as devise or sell or otherwise dispose of real and personal property; and

WHEREAS, N. C. Gen. Stat. § 153A-76 provides broad powers to the Board of Commissioners to organize county government and set the duties of county officers; and

WHEREAS, N. C. Gen. Stat. \$153A-82 (a)(8) provides inter alia that the County Manager shall perform any duties that may be required or authorized by the Board of Commissioners; and

WHEREAS, N. C. Gen. Stat. \$153A-176 allows a county to dispose of real and personal property pursuant to the provision of Chapter 160A, Article 12, which includes the granting of easements and rights of way in real property pursuant to N. C. Gen. Stat. \$160A-273; and

WHEREAS, the Cabarrus County Board of Commissioners receives many requests for routine utility and other easements and rights of way on the many parcels of real estate owned by the County, which includes the school properties that it owns, because of financing requirements; and

WHEREAS, some of these requests have short deadlines for approval because of the scheduling requirements for contractors and it may take too much time to have the matter scheduled for Board of Commissioners approval at its monthly regular meeting; and

WHEREAS, the Board of Commissioners would like to have the County Manager be able to approve such requests and execute the documents required to implement the request, without having to have the matter placed on the Board of Commissioners meeting agenda for approval.

NOW, THEREFORE, BE IT RESOLVED that the Cabarrus County Board of Commissioners delegates to the County Manager the authority to approve routine utility and other easements and rights of way on County real property and directs the County Manager to report to the Board of Commissioners each month on each such request that the County Manager has approved.

(F-10) County Manager - Land Acquisition

The County entered, or intends to enter into, purchase agreements for the following properties:

- 2892 Zion Church Road in Concord for a future animal shelter and household hazardous waste facility.
- 8274 Robinson Church Road in Harrisburg for a future elementary school.
- 5065, 5075, 5085, and 5175 Davidson Road in Davidson for a future park facility.

Each agreement permits the County an examination period to assess site feasibility for the intended use. Closing on each property will occur at the conclusion of the examination periods if project feasibility is established.

UPON MOTION of Vice Chairman Shue, seconded by Commissioner Measmer and unanimously carried, the Board authorized the County Manager to negotiate and execute all documents necessary for the acquisition of Tax Parcels: (1) 55298587250000 (+-5.8 acres) for a purchase price of \$825,000; (2) 55065843430000 (+- 25 acres) for a purchase price of \$1,500,000; and (3) 46732593490000 (+-2.7 acres), 46731660390000 (+-117 acres), 46733525350000 (+-1.5 acres), and 46733620930000 (+-5.6 acres) for a purchase price of \$1,500,000.

(F-12) Department of Social Services - Seniors' Health Insurance Information Program (SHIIP) Funding Increase

The Seniors' Health and Insurance Information Program (SHIIP) is administered in Cabarrus County by the Department of Social Services, Adult and Aging Services Division. Cabarrus SHIIP receives annual grant funding from the NC Department of Insurance, including an annual Federal MIPPA grant. The agency received notification of a MIPPA grant award in January 2024 for the period of September 1, 2023 - August 31, 2024. The amount of the actual award is \$6,878.00, which is slightly higher than the budgeted amount of \$6,608.00. A county match is not required.

UPON MOTION of Vice Chairman Shue, seconded by Commissioner Measmer and unanimously carried, the Board adopted the budget amendment for the Senior's Health Insurance Information Program.

(F-13) Planning- 2024-2025 Community Development Programs

Community Development Staff requested to make the regular submission for the Weatherization, Heating and Air Repair and Replacement program and Housing and Home Improvement programs as the applications and funding become available in the coming months. Additionally, staff requested to participate in any programs that Duke Energy or Blue Cross Blue Shield offer. The only match required for any of these programs is 10% for the Housing and Home Improvement program, which is part of the larger Home Care Community Block Grant program. Finally, staff is requested to make application for the regular HOME program allocation through the Consortium. The match amount is determined by the allocation of HOME funds and the projected match amount will be included in the annual budget process if approved. Staff proposed to use the funding toward building a new single-family home in Concord with Habitat for Humanity. If there are any funds left over from this project, staff would like to put those funds towards the Down Payment Assistance Program that was funded with 2023-2024 HOME funds.

UPON MOTION of Vice Chairman Shue, seconded by Commissioner Measmer and unanimously carried, the Board approved staff to submit applications for Weatherization, Heating and Air Repair and Replacement Program, Housing and Home Improvement, Duke Energy Programs, Blue Cross Blue Shield programs and the 2024-2025 HOME program and allow the County Manager to execute any necessary contracts subject to legal review.

(F-14) Sheriff's Office - Acceptance of Fees from the Interlocal Detention Agreement with Anson County

The Anson County Detention Center experienced overcrowding, which required them to temporarily move certain inmates to other facilities. The Cabarrus County Detention Center currently has available space to house these inmates at a rate of \$70 per day per inmate (which decided by the Cabarrus County Board of Commissioners on May 2, 2022). The Interlocal Agreement also states that all ordinary and extraordinary medical costs are covered by Anson County. The Memorandum of Agreement will not diminish the capacity, will not require additional staff, and will bring additional revenue to the County.

UPON MOTION of Vice Chairman Shue, seconded by Commissioner Measmer and unanimously carried, the Board approved the Memorandum of Agreement between Cabarrus County and Anson County.

(F-15) Sheriff's Office - Acceptance of NC Legislative State Grant - Bomb Squad Equipment

As part of a legislative appropriation through the North Carolina General Assembly, the Cabarrus County Sheriff's Office was awarded \$300,000.00 to

augment or replace aging bomb squad equipment. Newly acquired equipment will assist the Sheriff's Office in providing timely, well-coordinated, and proper response to high-probability bomb threats, improvised explosive devices, and other explosive items to ensure the safety of community members and sworn personnel. As this is a regional response team, the state funding helps offset the county expense of this team.

UPON MOTION of Vice Chairman Shue, seconded by Commissioner Measmer and unanimously carried, the Board approved the grant award and adopted the necessary associated budget amendment.

(F-16) Sheriff's Office - Acceptance of NC Legislative State Grant - Wellness Program and Bomb Squad Equipment

As part of a legislative appropriation through the North Carolina General Assembly, the Cabarrus County Sheriff's Office was awarded \$1,399,000.00 to implement a full Wellness Program to focus on the mental, physical, and emotional wellness of all employees of the Cabarrus County Sheriff's Office. This would include funding for a full-time employee to oversee and run the program, pay for needed equipment, training, and program materials, as well as funding to contract with an Embedded Behavioral Health Service that specializes in working with law enforcement employees.

(F-18) Tax Administration- Advertisement of 2023 Delinquent Taxes

The North Carolina General Statute 105-369 requires counties to report the amount of unpaid taxes for the current year. Included are liens on real property, less bankruptcies, and Property Tax Commission (PTC) appeals; it also requires the County tax collector to set the advertisement date for the delinquent property taxes. The current 2023 outstanding real estate property taxes are \$\$8,697,288.45 reduced by bankruptcies of \$171,134.32 and removing PTC appeals of \$97,244.82, which leaves a total report of \$8,428,909.31. Mr. Thrift requested approval of the advertisement to be held on March 24, 2024, and approval of the report for 2023.

UPON MOTION of Vice Chairman Shue, seconded by Commissioner Measmer and unanimously carried, the Board approved the report for the 2023 outstanding delinquent taxes that are a lien on real property and to order the Tax Administrator to advertise these liens on March 24, 2024.

(F-19) Tax Administration - Refund and Release Reports - January 2024

The Release Report contains taxpayers' names, bill numbers, valuations, tax amounts, along with the justifications for releasing the valuation/tax amounts for outstanding levies in accordance with N.C.G.S. 105-381. (H-4) Economic Development Investment - Fortius Capital Partners (Concord Commerce Park) - Public Hearing 6:30 p.m.

Samantha Grass, Economic Development Corporation, Project Manager, presented a request for an economic development investment for Fortius Capital Partners pursuant to NC General Statute 158.7.1. The industrial speculative development project, Concord Commerce Park, proposes to locate at the corner of Concord Parkway/Highway 29 and George Liles Pkwy, Concord with a projected investment between \$102,400,000 and \$125,000,000 in real property. A five-year industrial speculative grant equivalent to 85 percent of the ad valorem taxes on the increase in real property tax values was requested.

A lengthy discussion ensued. During the discussion, Ms. Grass and Page Castrodale, Economic Development Corporation, Executive Director, responded to questions from the Board.

Chairman Morris opened the public hearing at 8:54 p.m. The Public Hearing was posted on the County's website (www.cabarruscounty.us) on February 6, 2024 in accordance with Article 2, Administration, Section 2.1 (Use of Electronic Means to Provide Public Notices) of the Cabarrus County Code of Ordinances.

Naomi Hatchel, resident of Cabarrus County, stated she wanted what was best for the citizens of Cabarrus County and not the businesses.

Chris Cranston, a resident at 475 High Medows Drive, Concord, commented on the tax breaks and incentives for incoming businesses.

Mary Pat King, a resident at 6533 Derby Lane NW, Concord, shared her concerns with new industries receiving tax incentives.

Jim Quick, a resident at 126 Spencer Avenue NW, Concord, commented on business tax incentives for companies that will not bring jobs to the county.

Charles Stapleton, a resident of 4779 Rocky River Road, Concord, expressed concerns regarding commercial and residential sewer and water allocations.

Kathy Crawford, a resident of Stone's Throw neighborhood, Concord, expressed concerns regarding the elderly population and new business growth that was not definitively going to provide income to the County.

There was no one else to address the Board; therefore, Chairman Morris closed the public hearing at 9:04~p.m.

A discussion ensued amongst the board members.

Vice Chairman Shue MOVED to approve an economic development agreement (5 years, 85 percent) between Fortius Capital Partners and Cabarrus County, and to authorize the County Manager to execute the Agreement on behalf of the Board, subject to review or revision by the County Attorney. Commissioner Wortman seconded the motion.

Following further discussion, the MOTION carried by the following: Ayes: Chairman Morris, Vice Chairman Shue, and Commissioner Wortman; Nays: Commissioners Measmer and Furr.

(H-5) Finance - Updated 2024 Draw Reimbursement Resolution

Jim Howden, Finance Director, reported the reimbursement resolution for Afton Ridge was inadvertently not included in the original package. The County's bond counsel recommended that our reimbursement resolutions related to the upcoming Fiscal Year 2024 draw program be updated. The recommendation is for the resolution to be more specific in describing each project. The Board has approved the resolution already, no dollar amounts have changed, just the project description.

UPON MOTION of Vice Chairman Shue, seconded by Commissioner Measmer and unanimously carried, the Board approved the updated Reimbursement Resolution.

Resolution No. 2024-17

RESOLUTION DECLARING OFFICIAL INTENT TO REIMBURSE EXPENDITURES WITH PROCEEDS OF DEBT PURSUANT TO UNITED STATES DEPARTMENT OF TREASURY REGULATIONS

BE IT RESOLVED by the Board of Commissioners of Cabarrus County:

- 1. The Board hereby finds, determines and declares as follows:
- (a) Treasury Regulations Section 1.150-2 (the "Regulations"), promulgated by the United States Department of Treasury on June 18, 1993, prescribes certain specific procedures applicable to certain obligations issued by the County after June 30, 1993, including, without limitation, a requirement that the County timely declare its official intent to reimburse certain expenditures with the proceeds of debt to be issued thereafter by the County.
- (b) The County has advanced and/or will advance its own funds to pay certain capital costs (the "Original Expenditures") associated with financing, in whole or in part, (i) the design, acquisition, construction, installation and equipping of a new public library and active living center, including the acquisition of necessary land, easements and rights-of-way, (ii) site development, (iii) any and all related utilities relocation and (iv) various real and/or personal property improvements related to any of the foregoing (collectively, the "Afton Ridge Library and Active Living Center Project").
- (c) The funds heretofore advanced or to be advanced by the County to pay the Original Expenditures are or will be available only on a temporary basis, and do not consist of funds that were otherwise earmarked or intended to be used by the County to permanently finance the Original Expenditures.
- (d) As of the date hereof, the County reasonably expects that it will reimburse itself for such Original Expenditures with the proceeds of debt to be incurred by the County, and the maximum principal amount of debt to be incurred with respect to the Afton Ridge Library and Active Living Center Project is expected to be \$30,400,000.
- (e) All Original Expenditures to be reimbursed by the County were paid no more than 60 days prior to or will be paid on or after the date of, this declaration of official intent. The County understands that such reimbursement must occur not later than 18 months after the later of (i) the date the Original Expenditure was paid; or (ii) the date the Afton Ridge Library and Active Living Center Project was placed in service or abandoned, but in no event more than 3 years after the Original Expenditure was paid.
 - 2. This resolution shall take effect immediately.
