# (F-1) Appointments - Blended Community Child Protection Team (CCPT)/Child Fatality Prevention Team (CFPT)

A Child Fatality Review Team was convened by the State to conduct a fatality review whenever there is suspicion of abuse or neglect contributing to a child's death and a county Department of Social Services (hereafter, DSS) has had contact through its child welfare programs with the child or family within 12 months preceding the child's death. The purpose of the review is to enable the Division, the county DSS, state and local agencies, and the local community to identify important issues related to child protection and to take appropriate action to improve our collective efforts to prevent child fatalities. The review process is a collaborative, multi-disciplinary effort that involves representatives of the Review Team as outlined in statute. The Review Team will issue a formal, public report designed to stimulate system improvements. Whenever a person is criminally charged in the fatality, the

report will be reviewed by the local District Attorney to ensure that its content does not interfere with any criminal investigation or prosecution. Cabarrus County has consistently operated a blended CCPT/CFPT, which is permissible (and beginning 2025 will become a requirement). A list of individuals to fill seats (required by statute) on the CCPT/CCFT was provided for the Board's consideration.

# (F-4) EMS - Medical Supply Budget Amendment

Staff was made aware of a significant change in the way our medications are acquired. Historically, medications were acquired from Atrium at the completion of individual calls. Last week staff learned this process will end on June 30, 2024. As a result some changes within pharmaceutical policies will be needed (not a result of anything happening locally). A problem arises regarding predicting the funding needs. While purchasing from Atrium, we were able to benefit from the bulk purchasing power of Atrium. We have the capabilities at headquarters to accommodate this need. Therefore, it is requested to move funds in the amount of \$168,000 from Ambulance Revenue (00162730-6613) to Medical Supplies (00192730-9360) for FY24. A budget amendment will be required.

# (F-5) Sheriff's Office - Budget Amendment for Purchased Services

The Sheriff's Office has a budget deficit for purchased services for the detention center, specifically due to the increasing costs of invoices from the Department of Public Safety (DPS) to house juveniles that the county is required to fund. However, the Cabarrus County Detention Center continues to create revenue by housing inmates from other counties that have overcrowding or maintenance issues. The Sheriff's Office currently has \$177,660 in revenues specifically from housing these inmates and will be earning at least an additional \$56,700.00. Staff requests appropriation of inmate housing revenues in the amount of \$234,360.00 (00162130-6438 to detention center purchased services (0192130-9445). A budget amendment will be needed.

# (G-1) County Manager - Restructure Department of Social Services Legal Services

Dr. Aalece Pugh, Assistant County Manager, presented a PowerPoint presentation regarding the current state of legal representation for the Department of Social Services. Two options were presented at the Work Session for the Board's consideration option 1) hiring two attorneys and gradually eliminating use of contracted legal services for DSS programs and option 2) hiring one attorney to manage two of the three DSS programs, while continuing use of contracted legal services for the third program. If approved, staff commit to collaboratively working with Hartsell & Williams to develop an effective transition plan. The position will be promptly posted and filled to ensure a seamless transition. In the current fiscal year, Hartsell & Williams will continue rendering services while costs associated with the in-house position will be covered from lapsed salary. Following the conclusion of the contract on June 30, 2024, funds will be included in the FY25 budget. Option 1 will be to hire two attorneys (lead attorney and staff attorney) with a goal to onboard by July 1, 2024 and gradually phase out contracted legal services for the department of social services. Option 2 will be a graduated plan to hire one staff attorney immediately and second attorney following the assessment of the model while continuing contracted legal services for child welfare cases.

A discussion ensued. During discussion, Dr. Pugh; Evan Lee, General Counsel and Rodney Harris, Deputy County Manager; responded to questions from the Board.

**UPON MOTION** of Commissioner Measmer, seconded by Commissioner Wortman the Board authorized bringing child support and adult protective legal services inhouse and the creation of one full-time staff attorney position by the following vote: Ayes: Chairman Morris, Commissioners Measmer, Wortman and Furr. Nays: Vice Chairman Shue.

# (G-2) EMS - Renewal of Non-Emergency Transport Franchise Agreement with American Transmed Public Hearing $6:30~\rm p.m.$

Jimmy Lentz, Emergency Medical Services (EMS) Chief, reported American Transmed is the non-emergency EMS transport provider for Cabarrus County. The county has maintained a franchise agreement for the last three years with American Transmed. The agreement will expire in June, 2024 and staff requests renewal for another three years.
