## 4. Discussion Items - For Action

# 4.1 Cooperative Extension - Cannon Foundation Grant Budget Amendment

Tracy LeCompte, Cooperative Extension Director, presented a budget amendment to increase both revenues and expenses to accommodate additional funding awarded to Cabarrus County 4-H Afterschool Program through the Cannon Foundation.

Beverly Bollenbecker, 4-H Program Associate, presented an overview of how the grant is utilized. Cooperative extension received an additional \$5,000 from the Cannon Foundation Grant, totaling \$40,000. The funds will be used for the kids plus and afterschool 4-H programs. The programs will include cooking classes, educational kits for creative arts to science experiments, the National 4-H STEM science challenge, as well as collaboration with the Cabarrus Arts Council.

Ms. LeCompte provided additional comments on Cooperative Extension's work in food and nutrition, agriculture, and 4-H youth development programs. The 4-H programs serve four delivery modes: in-school enrichment, camps and classes, enrichment clubs, and after-school. The grant will also support another position to assist with youth development.

Chairman Morris expressed appreciation to  ${\tt Ms.}$  LeCompte and her team as well as the Cannon Foundation.

Kelly Sifford, Assistant County Manager, provided an update to include an advertising requirement that is needed and will take place prior to the regular meeting on October 21, 2024.
