Ordinance No. 2025-05

AN ORDINANCE DECLARING 4355 RIMER RD., CONCORD, N.C. UNFIT FOR HUMAN HABITATION AND ORDERING DEMOLITION

WHEREAS, N.C. Gen. Stat. \$ 160D-1201 and -1203 authorizes the Board of Commissioners to adopt an Ordinance declaring the subject property unfit for human habitation and ordering the demolition of same; and

WHEREAS, as set forth below the owner of the subject property has been given a reasonable opportunity to bring the property into conformity with the Housing Code and has failed to do so; and

WHEREAS, the Cabarrus County Board of Commissioners believes that this Ordinance is necessary to welfare, health and safety of the community:

NOW, THEREFORE BE IT ORDAINED as follows:

- 1. Capital Investments Solutions, LLC is the owner of the subject property located at 4355 Rimer Rd., Concord, N.C. 28025 and having Cabarrus County Tax ID Number 56538251200000. The most recent deed to this property is attached hereto and incorporated fully herein by reference;
- 2. 4355 Rimer Road is uninhabitable. It is missing some of the exterior walls, and part of the flooring system. Due to the length of time it has been in this condition, and due to the lack of response from the property owner, it is also deemed to be an abandoned structure pursuant to G.S. 160D-1201(b);
- 3. The owner of the property has been served with three Notices of Violation as described herein, directing them to repair, remove or demolish the subject property due to these conditions;
- 4. The property owner has been served with three Notices of Violation on this property. Each Notice informed the property owner of their right to appeal the Notice to the Chief Building Inspector;
- 5. That on January 23, 2023, a first Notice of Violation was mailed to the record owner of the property directing the removal or abatement of the nuisance. The property owner did not appeal this Notice of Violation, or take any action to improve the conditions. At this time, the structure was tagged as "unsafe" by the County, and the County ordered the disconnection of electrical service to the property;
- 6. That on February 12, 2024, a second Notice of Violation was mailed to the record owner of the property directing the removal or abatement of the nuisance, for the same conditions set forth in the first Notice of Violation. The property owner did not appeal this Notice of Violation, or take any action to improve the conditions;
- 7. That on October 16, 2024 a third Notice of Violation was mailed to the record owner of the property directing the removal or abatement of the nuisance, for the same conditions set forth in the first and second Notices of Violation. The property owner did not appeal this Notice of Violation, or take any action to improve the conditions;
- 8. Pursuant to G.S. 1600-1201(b) and -1203(5), this Board is empowered to order the public officer(s) of Cabarrus County to proceed to effectuate the repair, removal or demolition of the subject property with respect to this particular property;
- 9. This Board finds that pursuant to G.S. 1600-1203(5) the property owner has first been given a reasonable opportunity to bring the property into conformity with the housing code, in that over two years has passed since the first Notice of Violation was issued, the property was tagged as being uninhabitable, and power to the property was disconnected;
- 10. The cost to repair the property on information and belief exceeds 50% of the current value of the dwelling, therefore, demolition of the structure is the only appropriate remedy.

IT IS, THEREFORE, ordered by this Ordinance:

- 1. 4355 Rimer Rd., Concord, N.C. 28025 is declared to be unfit for human habitation and abandoned, and shall be demolished by Cabarrus County forthwith;
- That the costs of the demolition shall constitute a first lien on the property;
- 3. That the property owner shall be invoiced for the cost of demolition within 30 days of completion of same. If said invoice is not paid within 30 days of the mailing of same, then the County shall execute on the lien to recover the costs incurred.

(F-4) Construction Standards - Proposed Permit Fee Schedule From Fee Study

(F-6) Emergency Management - Cabarrus Stanly Union Regional Hazard Mitigation Plan Adoption

The adoption of the Regional Hazard Mitigation Plan by resolution for Cabarrus County was a critical step in enhancing the county's resilience to natural hazards such as floods, hurricanes, and severe storms. This plan will provide a comprehensive strategy to reduce risks, protect lives and property, and improve community preparedness.

The key benefits will include access to critical funding at both the federal and state levels, improve disaster preparedness leading to faster recovery, enhance community protection by identifying vulnerable areas and prioritizing mitigation efforts and ensure compliance with Federal Emergency Management Agency (FEMA) requirements for disaster-related financial assistance and support.

UPON MOTION of Commissioner Wortman, seconded by Commissioner Pittman and unanimously carried, the Board approved the Cabarrus-Stanly-Union Regional Hazard Mitigation Plan and adopted the related resolution.

Resolution No. 2025-04

RESOLUTION ADOPTING THE CABARRUS STANLY UNION REGIONAL HAZARD MITIGATION PLAN

WHEREAS, the citizens and property within Cabarrus County are subject to the effects of natural hazards that pose threats to lives and cause damage to

property, and with the knowledge and experience that certain areas of the county are particularly vulnerable to drought, extreme heat, hailstorm, hurricane and tropical storm, lightning, thunderstorm wind/high wind, tornado, winter storm and freeze, flood, hazardous material incident, and wildfire; and

WHEREAS, Cabarrus County desires to seek ways to mitigate the impact of identified hazard risks; and

WHEREAS, the Legislature of the State of North Carolina has in Article 5, Section 160D-501 of Chapter 160D of the North Carolina General Statutes, delegated to local governmental units the responsibility to adopt regulations designed to promote the public health, safety, and general welfare of its citizenry; and

WHEREAS, the Legislature of the State of North Carolina has enacted General Statute Section 166A-19.41 (State emergency assistance funds) which provides that for a state of emergency declared pursuant to G.S. 166A-19.20(a) after the deadline established by the Federal Emergency Management Agency pursuant to the Disaster Mitigation Act of 2002, P.L. 106-390, the eligible entity shall have a hazard mitigation plan approved pursuant to the Stafford Act; and.

WHEREAS, Section 322 of the Federal Disaster Mitigation Act of 2000 states that local governments must develop an All-Hazards Mitigation Plan in order to be eligible to receive future Hazard Mitigation Grant Program Funds and other disaster-related assistance funding and that said Plan must be updated and adopted within a five year cycle; and

WHEREAS, Cabarrus County has performed a comprehensive review and evaluation of each section of the previously approved Hazard Mitigation Plan and has updated the said plan as required under regulations at 44 CFR Part 201 and according to guidance issued by the Federal Emergency Management Agency and the North Carolina Division of Emergency Management.

WHEREAS, it is the intent of the Board of Commissioners of Cabarrus County to fulfill this obligation in order that the County will be eligible for federal and state assistance in the event that a state of disaster is declared for a hazard event affecting the County;

NOW, THEREFORE, be it resolved that the Board of Commissioners of Cabarrus County hereby:

- 1. Adopts the Cabarrus Stanly Union Regional Hazard Mitigation Plan.
- 2. Vests Cabarrus County Emergency Management with the responsibility, authority, and the means to:
 - (a) Inform all concerned parties of this action.
 - (b) Cooperate with Federal, State and local agencies and private firms which undertake to study, survey, map and identify floodplain areas, and cooperate with neighboring communities with respect to management of adjoining floodplain areas in order to prevent exacerbation of existing hazard impacts.
- 3. WHEREAS, the Cabarrus County government recognizes the opportunity to leverage these state funds to address critical infrastructure needs without burdening local taxpayers; and

WHEREAS, this project will be funded exclusively through state dollars, requiring no local matching funds from Cabarrus County.

NOW, THEREFORE, BE IT RESOLVED, that the Cabarrus County Board of Commissioners hereby expresses its support for the North Carolina Department of Transportation to receive state funding for the traffic safety improvements outlined above; and

BE IT FURTHER RESOLVED that the Cabarrus County government expresses its gratitude to the North Carolina Senate for its commitment of \$250,000 to support enhancing roadway safety in Cabarrus County.
