Jay White, Chairman, called the meeting of the Board of Elections to order.

Wilkerson made a motion to approve the agenda. The Board approved unanimously.

Edmond made a motion to approve the minutes from the November 3, 2025 meeting as edited. The Board approved unanimously.

Edmond made a motion not to object to 17 absentee photo ID exception forms. The Board approved unanimously. Norris made a motion not to object to 1 provisional photo ID exception form. The Board approved unanimously. Wilkerson made a motion to approve the attached Absentee applications. The Board approved unanimously.

The Board duplicated absentees 4 OVRs by following the procedures and security outlined in procedures for counting electronically transmitted ballots which the Board adopted.

The total ballot count for mailed in Absentees to date is 271.

Edmond made a motion at 5:46 to recess until the close of polls. The Board approved unanimously. White called the Board back to order at 7:40 in order to process additional absentees.

Wilkerson made a motion not to object to 3 photo ID exception forms. The Board approved unanimously.

Wilkerson made a motion to approve 10 CIV and 1 OVR absentee ballots. The Board approved unanimously

Newsome uploaded the results from absentee voting into the election software with a total of 282 ballots. Newsome uploaded the results from early voting into the election software. The grand totals corresponded with the total number of mailed absentees returned and approved and the total number of early voting ballots requested and documented.

Newsome began entering the totals from the USBs that were brought in from the precinct officials and the transfer in office while staff checked the totals to make sure the totals were matching up with the tapes brought in from the precinct and on the transfer.

The Board reconvened after all precincts reported and all mail-in absentees and early voting were counted and final unofficial totals were accumulated.

Ericson made a motion not to object to 6 provisional photo ID exception forms. The Board approved unanimously.

There being no further business to come before the Board, Norris made a motion to adjourn at 9:34 pm. The Board approved unanimously.
