#### (1) Call to Order

Chair Vicky Porter opened the meeting at 5:30 p.m.

#### 1.2 Conflict of interest statement

Chair Vicky Porter read the following and heard no response. ## 4.1 Education

Tammi Remsburg reported that her summer schedule has been busier than usual due to continuing preschool programs, helping with Parks camps and teacher professional development. She has several PDs on the schedule through the fall.

#### 4.2 Supervisor's Communications Report

Daniel McClellan gave the supervisor's report that David Williams is the new Division of Soil & Water Director. He also introduced Rick McSwain as our new area coordinator. He also mentioned the Area Fall meeting on October 11<sup>th</sup> in Fallston. Tammi will need a check for \$30 made out to the Area 8 SWCD from all who are attending at the next meeting on September 5<sup>th</sup>.

#### 4.3 Division Funds Report

Chuckie Bass reported that the Lost Acres projects were completed, and RFP turned in the Raleigh. Lorien Deaton is the new cost share person in the Division.

## 4.4 Conservation Easement Report

Daniel McClellan reported that before Shelby left, they put together the ranking sheet to determine which easements to start for this year. Because there has still not been a final decision from the federal money on the Sam Davis easement, the new applications will be for the state money only. The Soil & Water Foundation has a new employee whose specialty is easements. This person might be a helpful resource. Vicky Porter asked the Board to consider having an advisory board or mentor group to talk to potential easement owners in addition to staff. The easement specialist job has been posted and we start interviews soon.

Daniel also reported that the STRAP money for stream cleanup has been allocated for 2 additional projects. The administration fee is planned to be used to obtain a drone for easement monitoring.

## 4.5 Partner Report

Rick McSwain introduced himself as our new Area 8 coordinator with the Division of Soil & Water. He plans to attend at least half of our board meetings.

## 5.1 Ranking Sheet update

Chuckie Bass presented the updated cost share ranking sheet which includes the 3 streams that will be focused on for impaired and impacted money: Muddy Creek-Rocky

River, Upper Dutch Buffalo and Lower Dutch Buffalo. UPON MOTION by Kevin May, seconded by Jeff Goforth, and carried unanimously, the Board moved to accept the updated cost share ranking sheet.

## 5.2 2024 Easement Ranking

Daniel McClellan shared the ranking sheet with the Board and showed that Wilburn Williams Family Farm is at the top of the list. He asked permission to go to the commissioner's meeting to ask for the funds to start this process. UPON MOTION of Eddie Moose, seconded by Jeff Goforth and carried unanimously, the Board moved to have Daniel go to the BOC meeting to pursue grants for easements based off the presented easement ranking sheet.
