# (1) Call to Order

### 4.5 Partner Report

Rick McSwain reported that Julie Henshaw will become Deputy Director of the Division of Soil & Water and that there are some changes in the structure of the department in the works. There is additional funding for cost share and StRAP.

Daniel McClellan said that Mr. Bowman had called asking if the easement had been modified when the City of Kannapolis had run the greenway through the easement property. Daniel turned it over to the county attorney who said that the original easement was written with trails acceptable on the property.
