- (1) Call to Order
 - a. Vicky Porter started the meeting at 5:36 p.m.
- (2) Invocation
 - a. Tommy Porter gave invocation.
- (3) Conflict of interest statement
 - a. "In the interest of preserving public confidence in the actions of this Board, the chair reminds members of their duty to avoid any conflicts of interests and inquires as to whether any member knows of any conflict of interest or potential conflict of interest with respect to matters to come before the Board."
 - b. Vicky Porter read the statement. There was no response.

- i. Amy Cook said that the application request for conservation easement funding was presented to the Cabarrus County Commissioner's Work Session for Agricultural Growth Zone grant and to be matched with moneys from the Ned Hudson fund. The Commissioners will vote on it in two weeks.
