Jay White, Chairman, called the meeting of the Board of Elections to order.

Wilkerson made a motion to approve the agenda. The Board approved unanimously.

Ericson made a motion to approve the minutes from the October 21, 2025 meeting. The Board approved unanimously.

Ericson made a motion to approve the 18 photo ID exception forms. The Board approved unanimously. Edmond made a motion to approve the attached Absentee applications. The Board approved unanimously.

Wilkerson made a motion to hold early voting for the March primary at a site to be determined from 8:00 am to 7:30 pm on weekdays from February 12 to February 27 and on Saturday, February 21 and Saturday, February 28 from 8:00 am to 3:00 pm. The Board approved unanimously. The total ballot count for mailed in Absentees to date is 150.

Soles informed the Board that pursuant to NCGS §163-33.2, 10% of the DS200-Voting Tabulators were randomly picked, examined and votes tested on Tuesday, October 28, 2025. All DS200 Tabulators checked out perfectly. The serial numbers are as follows:

Staff is working through the second list where numbers were provided but they didn't validate. The list has a total of 1427. 1116 have been researched and 337 have been validated.
